**GENERAL NOTES:**

- Call Underground Service Alert (1-800-227-2600) 48 hours prior to digging.
- Provide shoring for all excavations per CAL-OSHA requirements.
- All work shall conform to the City of Red Bluff Land Division and Engineering Design Standards, and the Standard Specifications for Public Works Construction (Greenbook), 2006 edition as amended.
- Applicant is responsible for all job site safety.
- All trench backfill within the Public Right of Way shall be per Standard Plan No. 0200.
- Applicant to provide traffic control (auto and pedestrian) per the Work Area Traffic Control Handbook.
- Permit expires one year from date of issuance.
- Applicant agrees to guarantee all work within the Public Right of Way for a period of one year after final inspection.
- ( ) Call for inspection of forms prior to placement of concrete (**4 hour minimum advance notice required**).
- ( ) Call for inspection of water and/or sewer lines and connections prior to backfill (2 hour advance notice required).
- ( ) City of Red Bluff to tap existing sewer line. Applicant agrees to provide all materials, properly shore the excavation and pay the fully burdened labor costs.

*Note: Applicant waives any claim of liability or damages against the City of Red Bluff based on the issuance of this permit, on any subsequent court order declaring this permit invalid and on any future damages suffered by the applicant by reasons of the issuance of this permit or his reliance thereon, and agrees to do the work in accordance with City rules and regulations and is subject to City inspection and approval. Permittee agrees to hold the City of Red Bluff harmless from any liability arising out of the placement of this encroachment.*
